WEDDING FAQ'S

DO YOU TRAVEL TO PHOTOGRAPH DESTINATION WEDDINGS?

I love to travel and encourage my clients to take me with them on they're adventures. I am open to just about everything and the only added costs are for basic needs such as transportation and lodging. I have traveled to all the Hawaiian Islands, New York, Costa Rica, Florida, and various mountain locations throughout Colorado to provide photography coverage.

HOW DO WE BOOK YOU FOR OUR WEDDING?

Please contact me via email or phone, and fill out my contact form. A non-refundable retainer fee of \$500 is required to secure your date. Certain dates are more popular than others and I sometimes get booked a year in advance. The remaining balance on the package chosen is due one month prior to the event date.

DO YOU PHOTOGRAPH TRADITIONAL, FORMAL FAMILY PORTRAITS?

Yes, I photograph groups of the wedding party, family members and friends. I know that this is an important part of your day to have these pictures. I work quickly and efficiently to keep it from feeling like a long and drawn-out session.

WHEN IS THE BEST TIME TO DO THE POSED PICTURES?

Think carefully about when you want to do the posed pictures. Do you want them before the ceremony, after the ceremony or some before and some after. If you want to have more time with your guests, do them before; this decision may change the entire schedule for the day. Posed photos take 3-5 minutes each. I encourage people to do as many of the posed portraits before the ceremony as possible, but either way is fine with me.

If any photographs are to be taken before the ceremony, please ask those who'll be in pictures to show up at least 15 minutes prior to the time scheduled to begin. Also please figure in 30 minutes of down time prior to the ceremony so that we will not be in the way of arriving guests (I will take candid shots of guests at this time)

Whether pictures are taken before or after the ceremony, ask the people involved to gather in a specific spot (close to where we will take pictures) You may want to announce this at the rehearsal dinner or in welcome packets/bags.

WE ARE GETTING MARRIED IN A CHURCH, IS THERE ANY INFORMATION THAT YOU NEED?

Yes, please find out if there are any restrictions on photography. Can I use a flash during the ceremony?
Do I have to shoot from a specific location? Are there time restrictions before or after the ceremony to do posed shots.
If you have a preference, please let me know (& the minister if necessary)

SHOULD I WEAR EXTRA MAKEUP FOR PICTURES?

Some brides ask whether they need to wear extra makeup for the photography. Although makeup does benefit the photograph by adding a little more definition in the face, my advice is that you do what makes you feel most comfortable. Capturing good images really depends on whether you feel relaxed and comfortable about how you look.

IF WE WANT OUR PHOTOGRAPH TO BE USED IN A NEWSPAPER ANNOUNCEMENT, IS THERE AN ADDITIONAL CHARGE?

There is no extra fee to use photographs we have taken in newspaper announcements. Please let me know ahead of time that you will need one. I would appreciate a copy of the newspaper for my records.

WHEN WILL I RECEIVE MY PHOTOS?

I try to get your proofs to you before you leave the island. If this is not possible, you will receive your proofs 4-6 weeks after your wedding date. The proofs and negatives will be in a box - all is for you to keep. All prints will be numbered with the roll # in the right hand bottom corner negative number will be machine printed on the back in black.

I will softly edit taking out unflattering images or pictures where eyes are closed.
